#### SCHEDULED PUBLIC HEARINGS

The regular meeting was recessed and the Public Hearing regarding the Housing Finance Program and General Obligation Housing Development Bonds, Series 2024 was opened at 5:32 p.m.

Shannon Sweeney, David Drown Associates, Inc. discussed the St. James EDA has been working on the development of four additional rental housing units. It is their intention to issue housing revenue bonds backed by a general obligation pledge of the city (pledge of tax levy in the event of revenue shortfalls) to fund the construction of the proposed housing project. Minesota Statute 469.034 Subd. 2 provides the authorization for issuance of housing revenue bonds with general obligation pledge of the local unit government. Shannon also provided a summary of the requirements to work through this process. Discussion and comments were heard.
